- Possession and or use of illegal drug or alcohol; this includes possession of any prescription drugs not reported to client service worker.
- Disrespecting Staff or other clients, disorderly conduct, profanity, or destruction of property.
- · Weapons or firearms in the units or on the property.
- Domestic Violence (verbal or physical to adult or child).
- Unauthorized visitors in your unit.
- Absence from your unit overnight without prior authorization.

****** IMPORTANT******

It is important to understand that the landlord Tenant Act that is currently in place here in Washington State does NOT apply. You are entering into a program for temporary housing, and as such, you can be asked to leave at anytime should you violate any of the afore mentioned rules.
